New Regents Exams in Global History and Geography II and US History and Government

- ➤ New Regents Exam in US History and Government will be administered in June 2019; Information about the design of the test and item types will be released by summer 2017.

Notable changes in new Regents exams:

- ➤ Elimination of stand-alone fact based questions; multiple choice questions will be stimulus based questions (graphs, maps, charts, primary and secondary sources, political cartoons).
- > Elimination of thematic essay.
- > Students will respond to 3 sets of documents with 3 short answer questions for each for a total of 9 responses.
- Enduring Issues Essay will replace the Document Based Question essay. Students will respond to a given prompt after analyzing approximately 4 documents.

Results:

All of our science courses have high passing rates of students taking the exam for the first time. Within the passing students, here is the mastery breakdown:

Living Environment - 71 students at mastery = 46% of those that passed
 Earth Science - 46 students at mastery = 43% of those that passed
 Chemistry - 21 students at mastery = 33% of those that passed
 Physics - 24 students at mastery = 57% of those that passed

^{*}At the end of the last school year, there were some Physics students who were deeply affected by the passing of their classmates. As a result, these students did not attend school with regularity the last month, and it is within that subset of students those who did not pass the Physics Regents.

Highlights and the Future of the Science Department:

Our Physics program at all levels deserves to be highlighted. Enrollment is increasing year to year and on the June '15 Regents, 57% of the students who passed the exam did so at the mastery level. Students are engaged and enjoy the class, which is leading to deeper understanding of the Physics concepts.

Beginning with our 2016-2017 school year we are making a few scheduling changes regarding when students take courses.

- Accelerated 8th grade students will be taking Living Environment instead of Earth Science.
- All sophomores will be taking Earth Science. Exceptions to this will be students
 who come in from other schools already carrying an Earth Science class on their
 transcript, students who are enrolled in BOCES programs that do not have room
 in their schedule for it, and the accelerated 8th grade students, who will take
 Earth Science as freshmen.

We would like to change the culture of our school and how science is viewed. We need to have as many students as possible taking Regents science classes. Taking Earth Science will expose students to more and varied types of laboratory work and prepare students for the rigor of taking Regents Chemistry or Regents Physics.

We are predicting a drop in the Earth Science Regents passing rate next year as we work towards holding all students to higher expectations. We will not be discouraged should we experience these results because we know we are working towards a long-term goal.

An area that we are striving to improve is the enrollment rate in the Chemistry classes. We are trying to funnel students towards these classes by having them take Earth Science in 10th grade so there is not that large jump in expectations from Living Environment to Chemistry.

We are offering 6 full year courses that allow students to earn college credits: Astronomy, Honors Chemistry, Honors Physics, AP Chemistry, AP Physics and AP Biology.

RESOLUTION OF THE BOARD OF EDUCATION FOR CORTLAND ENLARGED CITY SCHOOL DISTRICT

WHEREAS, the Board of Education of the Cortland Enlarged City School District (hereinafter referred to as the "District") desires to enter into a five year service agreement with the Onondaga-Cortland-Madison Board of Cooperative Educational Services (hereinafter referred to as OCM BOCES) in order for the OCM BOCES to furnish certain services to the District pursuant to New York State Education Law §1950(4)(jj), those services being lit fiber for high speed communications services in Co-Ser 601.

NOW, THEREFORE, it is

RESOLVED, that the Board of Education of Cortland Enlarged City School District agrees to enter into a contract with the OCM BOCES for the provision of said services to the District and not to exceed in total over the life of this agreement the annual amount of \$35,043 and associated CNYRIC charges with such amount to include annual OCM BOCES support costs and applicable taxes and surcharges, and with such support costs and applicable taxes and surcharges included at the current rate and subject to change as established in the OCM BOCES budget or mandated by any federal, state or local authority.

This amount may be amended with the approval of both parties. The District will be liable to OCM BOCES for early cancellation or withdrawal from this agreement to the same extent that OCM BOCES is liable to any vendor(s) of these services, including liability for applicable penalties or liquidated damages, and the District will also be liable for costs and expenses, including reasonable attorneys' fees and disbursements, incurred by OCM BOCES as consequence of any such early cancellation or withdrawal. Payment will be made as part of a regular annual OCM BOCES contract for services. Further, this agreement is subject to the approval of the Board of Education of OCM BOCES. This contract will be for a maximum period of five years commencing on or about October 4, 2015.
