The Cortland Enlarged City School District (CECSD) has contracted for a minimum speed of 325 Mbps through the CNYRIC via a CoSer agreement. The contracted speed meets the requirements set forth by SSBA requirements and that of the FCC E-rate modernization order. (Order \P 34-38) CECSD has a student enrollment count of 2,500.

3. Describe how you intend to use Smart Schools Bond Act funds for high-speed broadband and/or wireless connectivity projects in school buildings.

The Cortland Enlarged City School District (CECSD) has submitted an initial Smart Schools Investment Plan to address limited WiFi capacity and concentration. The initial SSIP has been approved by the Smart Schools Bond Act review committee. The following summary identifies the current state of wireless connectivity as a result of SSBA year to date expenditures:

Three hundred Aruba access points are now installed and functional. The CECSD wireless SSIP allowed for 1000Base-T access points in <u>ALL</u> educational spaces. Each classroom now has a 1Gb connection back to its corresponding data closet. All data closets are connected through a 10Gb connection.

The projected cost of the CECSD wireless project identified in the initial SSBA investment plan was offset by qualifying E-rate funding. CECSD received E-rate approval while the first SSBA submission moved through the SSIP approval process. E-rate funding allowed for \$101,564 in reimbursement for the aforementioned wireless project. CECSD intends to pay the outstanding balance of the total project cost with approved SSBA funding. The overall project cost of \$198,666 less qualified E-rate funding, leaves a balance of \$97,102 to be paid through SSBA invoice submissions. \$277,898 of the initial approved SSBA SSIP remains outstanding for connectivity related needs.

For the purposes of this amendment request, CECSD currently has 15 legacy standalone physical servers. The current inventory of servers are now approaching 7+ years in service. The current data center has become increasingly problematic in the critical role of providing file, print, database, storage, and application connectivity services for the district. The approval of this amendment request will allow the district to procure a virtual server environment. A new environment will allow the IT staff to retire legacy equipment, deploy a robust fault tolerant environment, and adopt a disaster recovery plan to reduce the likelihood of interruption in service to students and staff.

The district is proposing the elimination of all legacy servers. The deployment of a VMware environment scaled to three hosts along with adequate storage of ~20TB has been proven to be highly effective in districts of similar size and scope. The VMware solution will serve all educational spaces across 6 buildings. (1 Senior High/Junior High and 5 Elementary Schools) The environment will provide IT staff with centralized management and comprehensive backup to address shortcomings in the ability to retain and restore services in a timely manner.

Curriculum and Instruction "What are the district's plans to use digital connectivity and technology to improve teaching and learning?)

The replacement of legacy Wireless Access Points, as part of the approved SSBA connectivity plan, extended wireless coverage to all educational spaces while increasing throughput by a multiple of 10. This upgrade has had an immediate impact on CECSD's campus wide 1:1 student device initiative as the delivery tool for curriculum, instruction, and conduit to worldwide informational resources. Wireless capacity and mobile learning devices work in tandem with a multitude of digital based curriculum options available to the classroom student and educators alike. Disseminating tasks, monitoring individual student progress, and performing ad-hoc formative assessments are made possible by bridging the gaps between technology and curriculum delivery.

The district direction includes, "Project Based Learning" and "Flipped Classroom" initiatives along with adopting G-Suite offerings. Supporting technologies rely on a robust wireless connection to allow Teachers to project wirelessly, monitor student screens, and take control when warranted. Wireless based technologies that rely on both hardware and software provide a controlled environment to keep students on task and deliver dynamic assessment.

The proposed Virtual Server environment included in this addendum fully supports and aligns with Curriculum and Instruction initiatives. Purging legacy server equipment builds upon the success of the newly installed wireless environment made possible by SSBA funding. The replacement of legacy equipment providing file, print, storage, application, and database services aligns with all facets of Curriculum delivery. A VMware environment will mitigate downtime and increase the speed of which network resources are accessed district wide. The virtual environment is the last remaining vulnerability within the district infrastructure and the most likely point of failure. Approval of this addendum will afford CECSD IT staff the opportunity to address this shortcoming and significantly enhance performance for all stakeholders within the district.

Appropriate due diligence has been achieved through a manufacturer based evaluation pilot. Aruba wireless solutions provided equipment to CECSD for the purposes of real time testing in a production environment. Access points were provided along with appropriate wireless controller offerings. Pilot equipment was installed, operational, and in use for 90 days. Target pilot areas included those with the highest concentration of wireless access to district broadband.

CECSD successfully completed an infrastructure upgrade project during the summer of 2016. The upgrades included new fiber cabling, switches, and a core to facilitate 10Gps inter-connectivity between all district data closets. Specifically the PoE capable Gigabit switches in all data closets have enough port capacity to provide connections to all access points included within the approved SSBA investment plan. The upgraded infrastructure allows for future expandability to meet the upward trend for bandwidth capacity whether the connection is wireless or cabled.

Three hundred Aruba access points are now installed and functional along with redundant controllers. The CECSD wireless SSIP allowed for 1000Base-T access points in $\overline{\text{ALL}}$ educational spaces. Each classroom now has a 1Gb connection back to its corresponding data closet. All data closets are connected through a $\overline{10}$ Gb connection. All connections are secure and managed utilizing software controls and Aruba management solutions meeting the latest standards for security and encryption.
